THEMES AND CONTENT related to the project topic.

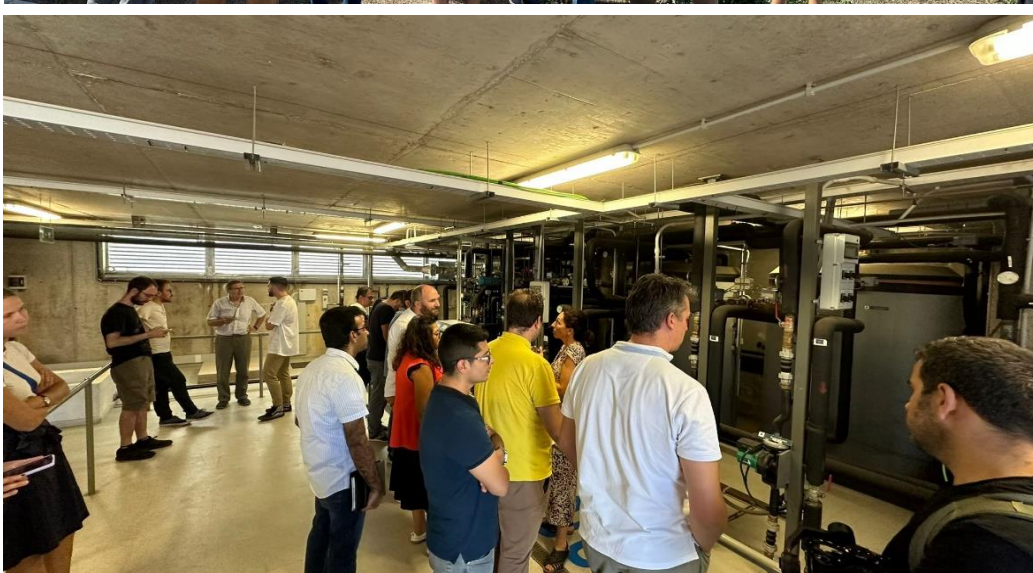
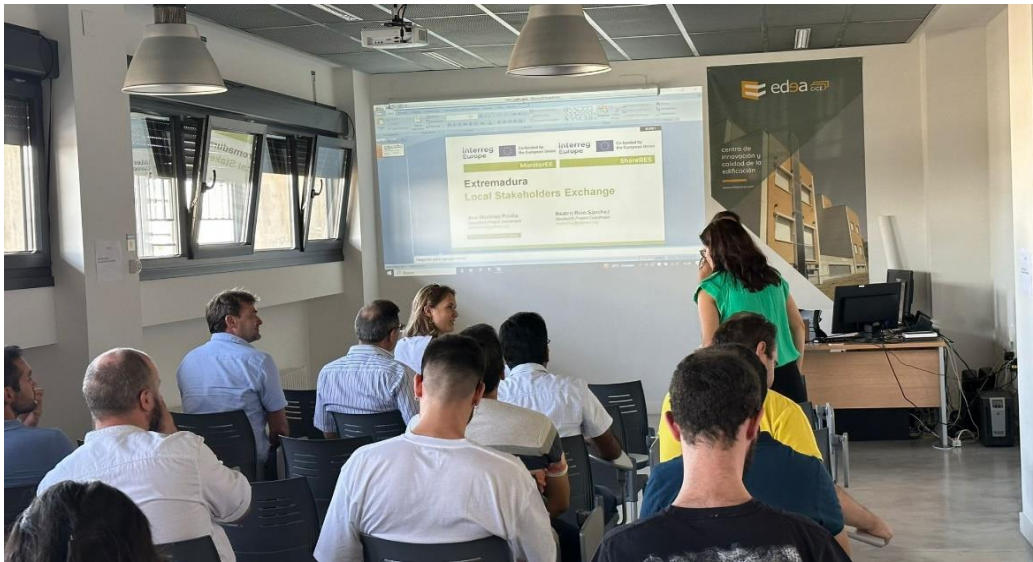
- 1st - **EDEA Project:** The EDEA project involves the monitoring of two twin buildings. The first, referred to as the "reference house," is constructed according to the specifications employed in Extremadura for the Special Plan. The second one is the "Experimental house," which incorporates various sustainable measures and renewable energy sources (RES). Both of these buildings are monitored to assess comparative data, which will enable the improvement of energy efficiency measures within public housing.
- 2nd - **Iberian Energy Storage Research Center:** The CIAE is responsible for addressing technological and scientific challenges related to the management of green energy, including:
 - Energy storage utilizing various technologies.
 - Development of innovative concepts within the Circular Economy.
 - Hydrogen generation.
 - Thermal energy storage.
 - Technical-economic analysis, life cycle analysis, circular economy, and the analysis and regulation of energy systems.

OBJECTIVES TACKLE AND BENEFIT GAINED DURING THE EVENT

The study visit enables regional stakeholders to become aware of the various projects currently underway in Extremadura. Furthermore, it serves as a platform for individuals from different entities to establish deeper connections and exchange experiences.

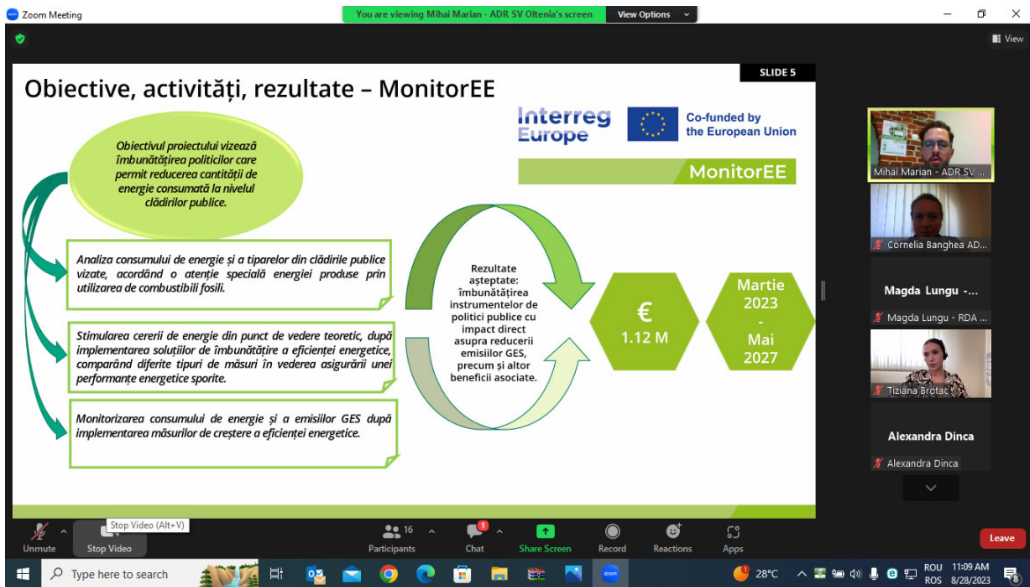
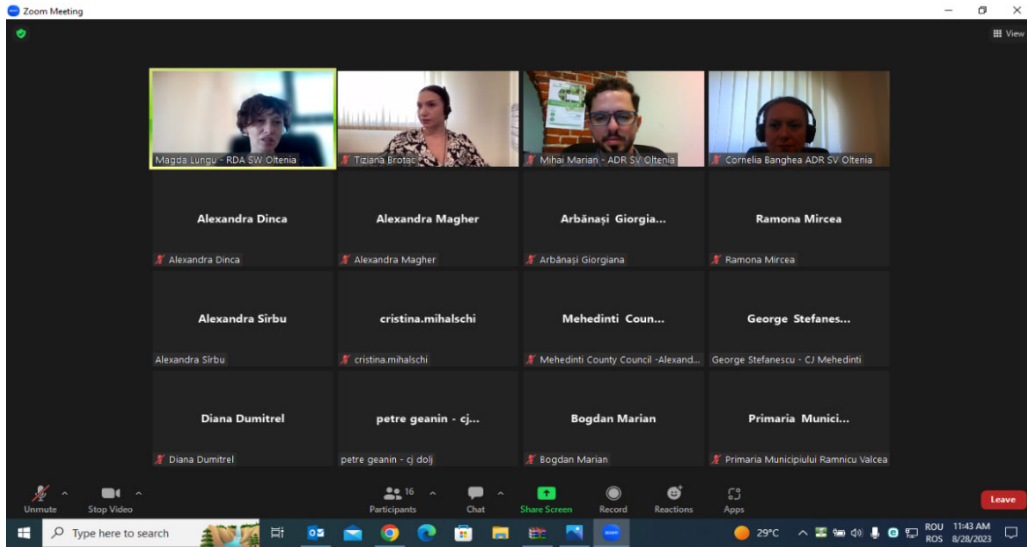

The expected results will enable significant reductions in greenhouse gas emissions as well as other associated benefits. The involmment of stakeholders in the project activities as regional actors, contributes directly to the identification of good practices and development strategies for the energy transition, as well as to the elaboration of the action plan in order to support the implementation of energy efficiency programs. Monitoring investments and analyzing real energy savings is essential for optimizing the spending of allocated public funds.</p>

During this LSM, we have highlighted the importance of sharing best practices between the different partners and the importance of study visits to discover and better understand local innovations in Europe. We explained to the partners how we have built our methodology (the starting point that is to say our instrumentation study, methodology stances, sample, issue, first outcomes and limits). From this methodology, we would like to develop a tool, a simple energy assesement headed to co-owners, that will give information about real energy consumptions before and after retrofiting. It will allow co-owners to start their building retrofiting.
